# 04 | Unique Features of Hanshin GSDS

- Hanshin GSDS develops and teaches new theoretical and practical approaches to development studies that emphasize balanced development between human beings and environment.
- Hanshin GSDS emphasizes a multidisciplinary approach to development studies to differentiate between traditional approaches which generally underscore economic development.
- Hanshin GSDS combines theory and practice to build student capabilities, from which students can tackle real-world programs and devise related projects and policies.
- Hanshin GSDS students are given a unique study abroad opportunity at the University of California, Berkeley, for one semester (or one semester and one summer session).
- Hanshin GSDS provides active assistance in job placement in Korea or foreign countries, in line with students' career plans.
- The instructional language of Hanshin GSDS is English. However, studying Korean is highly recommended for international students while they study at the program.
- The length of study at Hanshin GSDS is normally two years, or four semesters.

# 06 | Field Trip Studies and Internships

# 08 | Master of Development Studies

Hanshin GSDS offers a Master of Development Studies program. Starting from Development Cooperation Concentration in the first year, the Concentrations will be gradually added over time. The first year program aims at educating future specialists in issues and policies of international cooperation toward development, using a variety of socio-political and political economic perspectives. All students must fulfill minimum 30 credit hours of courses, including 6 hours of Master thesis writing. Students can choose to take 9 credits at the University of California, Berkeley for the third semester. The Concentration will eventually include the following:

- New Development Theory and Development Cooperation
- Economy and Industrial Development
- Regional and Social Development
- Education and Culture in Development
- Politics and Public Administration for Development
- Science, Technology, and Development

#### **Concentration I: New Development Theory and Development Cooperation**

In the core of New Development Theory is the coexistence of the ecological environment and human society, balance between the spiritual and material worlds, and the codevelopment of developed and developing countries as a result cooperation. Being one of the key areas of Development Studies, Development Cooperation deals with fundamental questions of foreign aid, official development assistance (ODA), international loans with governmental underwritings, international assistance by multilateral organizations, and other types of critical international assistance program undertaken by international organizations, civilians, and non-governmental organizations (NGOs). This subfield prepares students to be experts in ODA and aid project management, financial and foreign currency analysis, and new project development. Courses include ODA Project Management, OECD and Development Assistance, International Organizations, Money and Development, International Commerce/ Investment and Development, Foreign Currency Management, NGOs, and Development Cooperation for North Korea.

#### **Concentration II: Economy and Industrial Development**

Economy and Industrial Development deals with traditional issues of economic development over a wide spectrum of areas which include economic growth, development models and strategies, sustainable development, industrialization and industrial policy, enterprises and entrepreneurship, and global business management. Some courses in this concentration include Development Theories, Political Economy of Development, Industrial Policy for Development, Environment and Sustainable Economy, Regional Integration, International Finance Management, and New Theories on Entrepreneurship and Business Development.

#### **Concentration III: Regional and Social Development**

Region and Social Development focuses on the symbiosis of the ecological system and the development of regional communities. The Korean experience of the New Community Movement or 'Saemaeul Movement' will shed some new light on the theoretical and empirical issue of regional development. The social responsibility of corporations and the transnational migration of people, goods, services, finances, and corporations will provide challenges and opportunities to world peace and reconciliation of ethnic and regional conflicts. Courses include Comparing Regional Economies, Urban and Rural development, Social Overhead Capital Development, Regional and Community Development, Corporate Social Responsibilities, Migration and Development, and Saemaeul Movement.

#### **Concentration IV: Education and Culture in Development**

Education and Culture plays an important role in successful development. Students in this concentration will explore how education and culture shape a nation's developmental trajectory with specific questions of the formation and management of social capital, national education and education content, educational reforms, culture changes, and organizational innovation. Some of the courses in this concentration include Education and Development, Social Capital, Human Resource Management and Policy, Job Training and Employment, Culture, Religion and Development, Confucian Capitalism, and Hallyu (the Korean Wave).

#### **Concentration V: Politics and Public Administration for Development**

Politics and Public Administration engages students with the guestion of the development nation, national development management, and political leadership and bureaucracy. The state plays pivotal roles in economic planning and implements comprehensive policies of

and Development Administration, Democracy and Economic Development.

#### Concentration VI: Science, Technology, and Development

Science and Technology concentration deals with technology pursuit, technology transfer and technological capacity building, innovation and competitiveness. Policy issues involving the development of science and technology in developing countries also receive focal attention in this subfield. Some of the courses in this concentration include Science Technology Planning and Policies, Technology Transfer, Strategies of Technology Pursuit, Innovation and the Knowledge Economy, Technology and Intellectual Property Management, and Green Innovation.

# 11 | Scholarships

Hanshin GSDS students may pursue scholarships and other funds provided under the auspices of the central and local governments as well as the private sector. At Hanshin GSDS, all international students will be awarded scholarships (30 to 100 percent of tuition waiver) based on academic caliber and performance.

## 12 Accommodation

During the regular academic year, students can reside in the Hanshin dormitory.

# 13 | Regular Semesters

The regular semester consist of a fall semester (from September to December) and a spring semester (from March to June) each year. There are two breaks in a year: the winter break (from late December to February) and summer break (from late June to August).

# 14 | Admission Procedures

All candidates must be graduates of a bachelor's (or equivalent) degree program at a recognized college or university in Korea or abroad (a total of 16 years of education in primary, secondary, and tertiary institutions with national or international accreditation). Admission is based on a highly selective process. Key emphasis is placed on undergraduate GPA, statement of purpose, letters of recommendation, work experience, language proficiency, and interviews. Entrance requirements and admission procedures differ for Korean and non-Korean citizens. # 17 | Expenses for a semester in Berkeley

The expenses for a semester in Berkeley will fall in line with the Berkeley's regulations.

All applications to the program should have completed 16 years of primary, secondary, and tertiary education in each country of their residence. Graduates from both nationally- and internationally-accredited institutions of higher learning that offer undergraduate degrees in all areas of academic disciplines will be accepted for

Application materials include: Hanshin GSDS application forms (downloadable from our website), official TOEFL or IELTS score reports sent directly to Hanshin GSDS from the testing services, transcripts from all undergraduate universities attended, two letters of recommendation from either university professors or career supervisors familiar with the applicant (forms included), and an essay indicating applicants' plan

All applicants will be automatically considered for scholarships that range from 30% to 100% tuition waiver. Full scholarships that cover tuition, room and board, and health insurance are available for a limited number of students, while partial tuition

# 01 | Introduction to the Application Form

#### WELCOME

Thank you for your interest in Hanshin Graduate School of Development Studies (GSDS). We welcome all students who want to make a difference in their lives and change the world for better. Thus, we pursue for distinctive individuals ready to take this challenge, dedicate all efforts to study a desired field, and apply accrued knowledge and skills into practice after graduation. Applicants are treated equally regardless of sex, race, age, religion, disability and country of origin.

Admission is a competitive process; each application will be evaluated separately by the Admission Committee; all documents as academic transcripts, recommendation letters, and test scores are subjects to close scrutiny.

#### **APPLICATION ELIGIBILITY**

In order to be considered, applicant MUST fulfill the following requirements:

#### **Requirement 1: Educational Qualifications**

Applicants have to be graduated or are expected to graduate from a university. Applicants have to provide an embassy-apostilled copy of education documents.

#### **Requirement 2: Language Proficiency**

English is the language of instruction; Non-native speakers of English must possess a valid standardized test score (TOEFL PBT 550, CBT 210, iBT 80, IELTS 5.5, or TEPS 550) or acknowledge to possess such linguistic proficiency by Hanshin GSDS.

#### **HOW TO APPLY**

Currently, there are two ways to apply for admission:

Download the Application Form from our website (http://dept.hs.ac.kr/gsds/). Fill the application form in right on your computer, print it out, sign and attach photo, scan, and send it to our email (special@hs.ac.kr). Send the original of the other required documents. A completed application includes Application Form, Personal Statement, Letters of Recommendation, Transcripts/ Copies of Diplomas, and Application Fee.

#### **APPLICATION DEADLINES AND SCREENING SCHEDULES**

Students may start their academic program in the Spring Semester 2014. Admission period is from Nov 1st to Nov 15th and students are urged to apply as early as possible to ensure sufficient time for application screening and visa application procedures. Students who are admitted but unable to complete visa arrangements prior to the start of the semester may defer enrollment to the subsequent semester. The application deadline for Spring Semester is Nov 15th.

Students will be notified via e-mail about the application results. Online interview is schedule on Nov 22nd. All necessary official documents for visa obtainment will be sent by post and should arrive within a few days following result notification.

#### **ACADEMIC YEAR**

The Academic year is divided into two semesters, Fall and Spring, separated by two breaks. The Fall Semester begins in the first week of September, and the Spring Semester in the first week of March. Students will be notified via email about the details after the obtainment of visa. Students are expected to arrive in Korea prior to the start of the semester. During this period, students will be offered an Orientation program.

Hanshin GSDS program is designed to be completed within the standard period of Master's program (2 academic years).

Students must provide for the expense of program tuition without exception. However, if some students decide not to use dormitory and meal services on campus, they are free to look for housing and food off campus. Personal expenses may vary according to personal spending habits of the student. Normally, off campus housing costs vary about USD 300 to 800 per month and meal costs about USD 500 per month.


